6. Approval of JJCU statutes

Decision	6 votes to approve the statutes of JJAU and JJEU subject to approval of the amended JJIF statutes by JJIF Congress
7. WADA / Doping	
	Mr. Joachim Thumfart/ Nuvin Proag
Discussion	Mr. Proag and Mr. Thumfart point out the need to address some violations of the Anti Doping rules and emphasise the responsibility of the JJNOs for their athletes. It was stressed out as well that violations of sanctions are observed and reported by WADA. Especially commercial and private event organizers act reckless and do not care for these sanctions.
Conclusion	JJIF will recommend to their JJNOs to consider all kind of collaborations with private sector event organizers very careful.
